
The records of Horton, West, Berry, and Dombrowski are clearly outlined in the records of the Senate Internal Security Sub-Committee, the House Committee on Un-American Activities and the reports of state legislative investigating committees of Florida, Georgia, Mississippi, and Louisiana.

The continued operation of the Highlander Center at Knoxville is definitely a matter for the 1965 Tennessee Legislature to investigate.

The "Guide to Subversive Organization and Publications", revised and published as of January 2, 1957, to supersede Guide published on May 14, 1951, by the Committee on Un-American Activities, U. S. 


- 2. Cited as a Communist front which "is the foremost legal bulwark of the Communist Party, its front organizations and controlled unions" and which "since its inception has never failed to rally to the legal defense of the Communist Party and individual members thereof, including known espionage agents." (Committee on Un-American Activities, House Report 3123 on the National Lawyers Guild, September 21, 1950, originally released September 17, 1950.)
 - "To defend the cases of Communist lawbreakers, fronts have been devised making special appeals in behalf of civil liberties and reaching out far beyond the confines of the Communist Party itself. The President may be interested in the following information concerning Martin Luther King, Jr., which has been supplied by confidential sources of this Bureau who have furnished reliable information in the past. Clarence Jones and Ossie Davis recently conferred concerning the safety of King. Jones is a close advisor to King and during the mid-1950's held a position of leadership in the Labor Youth League, an organization which has been designated as subversive pursuant to Executive Order 10450. Davis is a well-known author and playwright. During the latter part of 1963 a national functionary of the Communist Party, USA, stated that Davis was then a Party member. During the recent Jones-Davis conference, Davis said he desired that President Lyndon B. Johnson's attention be called to recent threats on King's life and urge that the President move to protect King's life because "we cannot afford to lose him at this juncture." Davis said that "their" request should be dramatically made, pointing out that King is doing a job that the United States Government should be doing, and that it was mockery to talk about freedom in South Vietnam when "the one man who is defending it in Selma (Alabama) is in jeopardy." 



As you are aware, for some time King has been under considerable influence of Stanley Levison, a long-time communist, and Clarence Jones, who also has a communist background. More recently, Marry Wachtel has been coming to the fore as a principal advisor to King. Wachtel likewise has a communist background. 🗲 Jones recently related to Levison the details of a conversation Jones had had with Chauncey Eskridge (a Chicago attorney who is close to King) about King's relationship with Wachtel. According to Eskridge, King had caused great concern among many people in the Southern Christian Leadership Conference (SCLC) because of King's "over dependence" on Wachtel. Eskridge said that he had talked to King about the matter and was told by King that four or five months ago it was very difficult for King to reach Jones and therefore Jones recommended Wachtel to King. As a result, King made the practice of calling Wachtel ever since and, according to King, Wachtel had become "quite assertive and had a take-charge attitude." Eskridge has asked Jones to spend more time on King's business since Eskridge has suggested to King that King "pull back from Wachteh." Jones has indicated he will spend more time for King in the future. Levison told Jones that Wachtel found it very difficult to work b with other people and "that years ago when I (Levison) had the kind of relationship with King that Wachtel does now, Eskridge was a very good friend of mine and there was never any question of Negro-white differences." Levison said that one of the current problems is due to the fact that Wachtel never consults anyone except Bayard Rustin (another King advisor with a communist background According to Levison, the consensus in the King "camp" is that none of the advisors had ever tried to grab headlines or take charge, whereas Wachtel has done so. As an example, Levison pointed to the incident surrounding King's conferences with the President, Vice President, and Attorney General 2/9/65 and the fact that Wachtel's name appeared in the newspapers relative to the arrangements. The "Los Angeles Sentinel," a weekly newspaper, issue dated February 18, 1965, set forth an article captioned "Red Carpet Welcome Set for King Here Next Week." This article disclosed that King was scheduled to arrive at the International Airport, Los Angeles, at 11:00 a.m., February 24, 1965, via Delta Airlines Flight 983. This article set forth King's schedule of activities in Los Angeles as follows: Thursday, February 25, 1965 12:30 p.m. King will be featured speaker at the World Affairs Council meeting. King will be guest of honor at a benefit premiere of "The Greatest Story Ever Told" 8:00 p.m. film at the Pacific's Cinerama Theatre, which is sponsored by the Western Christian Leadership Conference. Actor Marlon Brando is general chairman of this event. Judge Sherman Smith is honorary chairman and Deputy D. A. Earl Broady, Sr., and Doctors Ruth Carter and Ross Miller are coordinators. King will be honored at a reception in the lobby of the theatre following the premiere. Friday, February 26, 1965 8:30 p.m. King will speak at the Hollywood Temple Israel.

AMERICAN NAZI PARTY OF THE WORLD UNION OF FREE ENTERPRISE NATIONAL SOCIALISTS, Also Known As The George Lincoln Rockwell Party



In his book "This Time The World," copyrighted in 1961, George Lincoln Rockwell identified himself as Commander, American Nazi Party of the World Union of Free Enterprise National Socialists (ANP - WUFENS), Arlington, Virginia.


The April 4, 1963 issue of "The Richmond News Leader," a Richmond, Virginia daily newspaper, reported that George Lincoln Rockwell had, on the previous day, again applied for the American Nazi Party to be chartered in the State of Virginia, but this request was turned down by the Virginia State Corporation Commission. This action was taken pursuant to an act of the 1962 Virginia Assembly which prohibits use of "Nazi" or "National Socialism" in a Virginia charter. This article further pointed out that Rockwell's party is presently chartered in the State of Virginia as the George Lincoln Rockwell Party.


On August 14, 1964, a source advised that the ANP -WUFENS was organized by George Lincoln Rockwell at his residence in Arlington, Virginia, on February 26, 1959, as an international "National Socialist" movement based on the German Nazi Party headed by Adolf Hitler. He added that Rockwell is the dominant force and personality in this party; that he is espousing a "line" of hatred against the Jews and Negroes; and that he is seeking, through speeches, distribution of literature and picketing, to establish a cohesive and dominant political party in the United States and in foreign countries.


According to the "Stormtrooper's Manual," an official publication of the ANP, the phases of ANP struggle for power are fourfold, namely, first "to make ourselves known to the masses;" second "the dissemination of our program and the truth about the Party;" third "organizing the people who have been converted to our propaganda;" and fourth "the attainment of power through the voters of the newly-won masses."



Negro-Crammed 'Pit' Mean And Troubled

Call it "The Pit". Magic City, Washington Heights, the downtown slum, or just the Central Negro District.

It is the place where 15,984 Negroes are squeezed between NW 5th and 28th Streets, and the Florida East Coast tracks and NW 7th Avenue. Few "oofays" (Negro slang for whites) live here.

This is where Frank Jaffe, a white lawyer, was killed by three Negro youths last Saturday night.

It is an oversized neighborhood with a tough street name like Goodbread Alley, an odor of open garbage and a clothesline of faded clean laundry. It's the backdrop for a Gershwin operetta. But it's real.

About half of the Negroes here work. The rest are too old, too young, too sick — or too pregnant.

For the older folks, a Social Security check is their salvation; for the young, direction; for the sick, medicine; and for the pregnant, welfare assistance.

An elderly couple sat on the wooden porch of their "shotgun" (shack) waiting for the check to arrive. "These people live from check to check. If they didn't have it, they wouldn't e.t," said mailman Woody Greene. "I can leave first class mail in any mailbox. But not a check. I have to hand deliver it or it disappears."

Three women and a graying man greeted Woody as he

approached their 50-unit apartment house on his bike. Two young Negro teenagers in unbuttoned shirts came to a door and asked: "Is Jimmy sleepin?" He was. It was 10:45 a.m.

A loose-lipped woman on the third floor yelled she was too sick to come down for her check. So Woody hurdled three flights with it.

"It's the least I can do," said Woody.

A white milkman feels at ease, too.

"People have been good to me in the five years I've worked here. They give me sandwiches, keep the bad guys off my back. They say, 'He's our milkman. Leave him alone.'"

He starts out at 2 a.m. five days a week.

Friday morning two men shot a milkman in the wrist and robbed him of \$200. The police caught the pair.


"Most of the trouble is caused by the newcomers. Every week someone new from a Georgia farm settles here. They're big on civil rights," said one Negro policeman curtly.

"Then their friends move in with them. They've got no respect for the law. They make it bad for everyone else," he continued. "Trouble is where you find it."

One white bar and package store owner had answers for his own questions.

"What really does a kid born here have? Nothing! He's got to move out and get an education to improve himself.

Jaffe Killer Manhunt A Gamble, Police Say

Miami's crime pocket was strangely quiet. Teenage gangs kept clear of their hangouts. Cops with shotguns patrolled empty streets.

The crackdown began last Saturday night when 55-year-old Frank Jaffe, a prominent white attorney, was gunned down in an alley of Miami's Central Negro District.

He was murdered while running from teenage robbers, police said.

The lawmen swarmed in. Working overtime shifts they hauled in scores of teenage gang members.

And when it was over, police had their suspects and lots more. In the process, they solved more than a dozen armed robberies.

It was the beginning of the end of the 7th Street Bulls.

The "Bulls" are one of many gangs in the Negro ghetto. Three of them last week were charged with murdering Jaffe. Eight more are in for armed robbery.

Police say this is just the beginning.

"With the information we have received in the past couple of days, we hope to crack several more of those young robber gangs," a Miami detective said.







King indicated that he believed white resistance to the Civil rights movement had begun to recede, although he stressed, on the other hand, the immense difficulties that remain.

He said that in Alabama he was receiving increased sympathy from white people for the Civil rights cause.

In support of his views that the Civil rights movement has resulted in progress, King said that most of the communities in the deep South had been complying with the Public Accommodations Section of the Civil Rights Act.

King said during the news conference that he would join with the Marchers who will leave Selma, Alabama, next Sunday (March 7, 1965) on a trek to Montgomery, Alabama, to petition Governor George C. Wallace to put an end to discrimination and remove obstacles to the registration of Negro voters in his state.

In conclusion, the article noted that King was scheduled to leave New York on Friday, March 5, 1965, for Washington, D. C., to confer with President Johnson on the proposed new voting-rights legislation.


Harry Wachtel said the march had to go forward and that it would be stopped, therefore, King did not have to active whether or not he would be violating the injunction. Ouite to the contrary, Wachtel said, he (King) had to face up to the fact that he would be held in violation and face it by not trying to weasle away from it. Furthermore, King's carching would go as far as the physical confrontation would take it, Wachtel opined. But for "us" to announce in advance on obedience to that "improper injunction" would be inadvisable. Wachtel said. Greenberg said in reply, that it was not announcing




Wachtel replied that "we" did it over their own free will last night, prompting Clarence Jones to remark, "That's the whole question." King said this is going to be won in the streets of Selma and I think this is very basic. This was not my position at six o'clock last night." 
Greenberg said he was in agreement because he did not think the injunction would be upheld for about 20 different reasons.


