# **BAD ROADS. TIRED MOB SAVE OTHERS**

Make Start for Imprisoned Blacks at Blytheville and Marion, but Quit Quest.

### BY RALPH RODDY.

(Memphis Press Reporter.) NODENA, Ark., Jan. 27.—"Cap, I want to be buried at Magnolia, Miss.

These were the last words spoken by Henry Lowry. negro murderer, who was burned at the stake last night; three-quarters of a mile east of here.

More than 500 persons stood by and looked on while the negro was slowly burned to a crisp. A few women were scattered among the crowd of Arkansas planters, who directed the grewsome work of avenging the death of O. T Craig and his daughter, Mrs. C. O. Williamson.

Not once did the slayer beg for mercy despite the fact that he suffered one of the most horrible deaths imaginable. With the negro chained to a log, members of the mob placed a small pile of leaves around his feet. Gasoline was then poured on the leaves, and the carrying out of the death sentence was under way.

Inch by inch the negro was tanly cooked to death. Every tew minutes tresh leaves were tossed on the funeral pyre until the blaze had passed the negro's waist. As the tlames were eating away his abdomen, a member of the mob stepped forward and saturated the body with gasoline. It was then only a few minutes until the negro had been reduced to asnes.

Muddy dirt roads held the lynchings in Arl ansas last night to one negro being toasted to death.



# WEDNESDAY The Memphis Press CE THREE CENTS **ROOPS ORDERED TO NODENA**, **GOV. M'RAE MAKES FRUITLESS** EFFORT TO REACH SHERIFF AS MOB PLANS FOR

Gov. McRae of Arkansas told The Press over long distance telephone this afternoon that he has not ordered state troops to proceed to Nodena, Ark., to prevent, threatened lynchings there tonight.

"I can't get in touch with Sheriff Blackwood of that county, so I wouldn't know who to send the troops to," . Gov. McRae said. "I understand that Sheriff Blackwood is at the Peabody hotel in Memphis and I have tried to telephone him there, but they say he is not in his room.

"What's the sheriff doing in Memphis? Why isn't he on his job? It's the worst outrage in the world to put a man to death without giving him a trial, and the sheriff that county should be getting busy. He hasn't called upon me for assistance.

"They had no business bringing that negro over the route they took. They should have brought him thru Arkansas and taken him direct to the penitenitairy at Little Rock.

"I had heard that the negro was taken off a train at Sardis, Miss., this morning, but I didn't know they were bringing him back to Arkansas."



# AVENGERS SET 6 O'CLOCK AS Lynching Hour

## Husky Arkansas Men Take Henry Lowry, Craig Slayer, From Train and Whisk Him Away.

MILLINGTON, Tenn, Jan 26.—A party of seven in two automobiles with Henry Lowry, negro murderer of two members of the Craig family on Christmas day, stopped here at 12 30 o'clock Wednesday afternoon on the way from Sardis, where they took the prisoner from officers, to Richardson's landing, where they will cross and be joined by a party waiting on the Arkansas side, prepared to lynch Lowry promptly at 6 o'clock.

The party stopped at Fowler's restaurant for lunch. The negro was taken into the restaurant and kept under observation while the party ate.

The negro said nothing, but showed the strain he was under. He realized that he was on his way to death. A number of Millington citizens were attracted to the restaurant, and a few accompanied the party to the landing. They are not expected to cross the river.

Nothing occurred to mar the serenity of the journey. The party ate leisurely and after finishing went to E. A. Harrold's store, where a quantity of rope was purchased. It was said that the rope would be used in place of chains for the automobiles. The road is very bad and slippery at the approach to the landing.

BARBARISM A NATIONAL CRIME.

The lynching of the negro Henry Lowry by an Arkansas mob near Nodena, in that sizete, an account of which appeared in these columns Thursday morning, was accomplished with something more of diabolism than usually attends such lawless outbreaks. There bave been frequent instances of burning victims, but, it has usually been done after death. In this instance the man was bound to a heap of dry timber, his hody saturated with kerosene and then burned and toriused until death ended his agony. The governor of Arkansas has made some perfunctors remarks about the enormity of the crime, and Threatens an investigation, but that will be about all there will be to it

It has long since ceased to be said that these mobs are made up of vagabonds, toughs, bums and vicious idlersthis one was, apparently composed of determined and responsible men, respected in the communities where they live and altogether representative of the sentiment of their neighbors. State authority will, therefore, hardly reach them.

In such circumstances, a great impulse will be given to the movement for

a federal law against this crime There will be those t ho, while objecting to federal interference in purely state affairs. will not be long in concluding that there may be a federal issue in the preservation of the civilization of the republic The most ardent state righter will hardly dispute the statement that burning human beings at the stake is barbarous, inhuman, savage and un-American The federal government may, without offense declare that such practices are repugnant to the spirit and the sort of the republic, and that those who indulge them are outlaws and enemies of their country and its institutions Treason is a national offense, and so may burning human creatures at the stake come to be a crime such as treason I ynch law run mad, as carried out by this incensate and inhuman mob, is a direct and flagitions issault upon the civilization of the American people and a wanton and unpardonable come evaluat the moral and solutional sense of the flation The nation may, therefore, decore that it riay, without violating the rights of any state, take cognizance of this pagan savagery and provide a penalty for it so drastic and severe as to render it exceedingly dangerous for future mobs to indulge it

**GOVERNOR IRATE AT** LYNCHING OF NEGRO

·· Will Ask for Law Providing for Removal of Weak-Kneed Officers.

Governor McRae last night characterized the burning of John Henry Lowery, negro, near Nodena, as "most disgraceful and inexcusable" and said he will recommend the paysage of legislation to provide for the removal of officers who do not pre vent lynchings of prisoners in their custody or within their juriediction The governor was first informed of Lowery's fate by a Gazette reporter Ever since the snegro's capture at El Paso, Tex, where he was taken for a double murder near Wilson on a double murder near winson on Christmas Day, the governor has ex-cried every effort to have the pris-oner placed in the penitentiary at Luttle Rock for safekeeping pending Little Rock for safekceping pending irral of his case, and thus far the only result obtained has been the assur-ance that the American Legion at Bittheville will do everything pos-suble to prevent the lynching there of two negroes who are held on charges of harboring Lowerv while posses while posses hunted him.

The telegram from Blytheville was received b the governor last night It acknowledged receipt of a message requesting that the Legion take ac tion to support the civil authorities and said "We will do all in our power to prevent lynching of negroes in juil here " The message was signed by Welch Foster, commander of the post at Blytheville Three negroes are held at Mariou who also are charg ed with aiding Lowerv

### Appeals to Legion Posts.

The governor's message to the Biytheville post and to R. E. Lee Wil son Jr., post commander at Wilson, which town is near Nodera, was sent yesterday afternoon it follows

"I call upon you as commander of the American Legion Post to use every means at your command in as sisting civil authorities to uphold las and order and prevent lynching the negro who will arrive at Nodena tonight. Pleme proceed there at once and co-operate with the civil authori-ties if possible, but I rely upon you and the ex-service map of the Amer ican Legion to stop lynching at all hazarda." No messago was received from Post Commander Wilson last night

This message was dispatched when the governor was informed of the raid of the lynching party upon the train at Sardis, Miss Previously Governor at Sardis, Miss McRde had sent telegrams, telephone messages and letters in an effort to have the prisoner brought direct to Inttle Rock. The Governor's Statement.

Governor McRae's statement in full tollows:

'I make no comment on the tound about way in which the negro was brought from El Paso I have no suf ficient facts before me, and it is pos sible that none of the many messages I sent by telegraph, telephone and let ter may have reached the officer in charge of the man. But I consider the happening most disgraceful and inex-cusable. The negro had surrendered and had consented to return without equisition, relying upon a fair trial by the cousts this I had promised him, considering that he would be brought directly here, where he could be held safely until the time of the trial.

"If shall recommend to the legislature the enactment of a law which will place the responsibility directly upon the officers having custody of prisoners, and will recommend some act by which a sheriff who permits. or does not prevent, the lynching of a or does not prevent, the tracking of a prisoner in his charge "bir r marged trom office in association as "ba negro was taken from an interstile train and brought from Answerppi unto Arkarsas where he was killed, the platter may come within the purview of federal authorities, and t is pos . ble that this occurrence may result in the enactment or federal statutes for the prevention of crimes which should be prevented by our county officients? officers '
