#### PRESS RELEASE

SYNOPSIS: THE ARREST OF HOWARD SAFFOLD, PRESIDENT OF THE AFRO-AMERICAN PATROLMEN'S LEAGUE

The arrest of Howard Saffold, President of the Afro-American Patrolmen's League, and Edgar Gosa and Ocie Brown, members of the Executive Board of Directors was, in our estimation, a racially motivated incident.

Two of the white officers involved in this incident, Officers Molloy and Domanski, are subjects of several brutality complaints that have been lodged against them by Black Citizens with the cooperation of the Afro-American Patrolmen's League. We believe that this, as well as their general racial attitudes toward the Afro-American Patrolmen's League, was the basis for their taking this most bizarre action against the League and their leadership. We believe that this incident typlifies white police officers attitudes toward Black citizens and is the reason why our office to date has received 855 cases by citizens complaining of improper police activity.

During the last month, the Afro-American Patrolmen's League has been conducting an extensive membership campaign throughout the City of Chicago which necessitates the visitation of stations during the hours of 3:00 P.M. and 11:00 P.M (during shift changes). These visits are made because the League has to obtain the written signature of all members on dues deduction forms which must be countersigned by a supervising officer. At the time of this incident Howard Saffold, Edgar Gosa and Ocie Brown were enroute to the 009th District which is located at 35th & Lowe.

On Friday, November 21, 1975, at approximately 11:00 P.M., Howard Saffold, President of the League along with Officers Ocie Brown and Edgar Gosa, League Executive Board Members, were stopped by two white plainclothes police officers. These officers alighted from their vehicle with guns drawn and demanded that the occupants of Saffold's vehicle get out of their vehicle, (the language used was "get out of that motherfucking car you Black bastards"). Howard Saffold identified himself as a police officer and identified the other two gentlemen as police officers also. While alighting from the vehicle, Saffold requested an explanation from the officers as to their conduct and why the necessity of drawing guns on police officers. He further requested that they call

the supervisor which is standard procedure. The officers instead called a "10-1", which is a police officer needs help call, and fifteen officers arrived on the scene. Howard Saffold and the other two officers were hand-cuffed behind their backs and physically thrown into a paddy wagon. During this entire episode at no time were Howard Saffold or the other officers told the reason for this unusual treatment or why they had been stopped. Racial abuse continued throughout. At no time did Howard Saffold or the other two officers resist arrest. Enroute to the station the driver of the police squadrol continued racial abuse directed both at Howard Saffold and the Afro-American Patrolmen's League. In addition, the driver of the van continued to purposely speed up the vehicle and slam on the brakes causing Howard Saffold and the others to fall on the floor of the van. The driver continued to laugh and use racial abuse.

When they arrived at the station they were taken from the squadrol and brought into the station and were placed in the lockup. During the entire time they were in the station racial abuse continued to be directed both at the Organization and at Howard Saffold and the other officers. Howard Saffold was given a ticket for negligent driving. This ticket had to be written by another officer because it was discovered that the two white officers who made the initial stop did not carry ticket books. When Howard Saffold was presented with his ticket he asked Officer Molloy his name and was he the officer who signed the ticket as a complainant. Molloy stated "none of your business you black bastard" and shoved Howard Saffold, Saffold considered this an attack on his person and struck Officer Molloy. Saffold and Molloy both signed complaints against each other for battery. The Watch Commander prepared Howard Saffold's complaint, Howard was sworn in by Officer R. White, a quasi-official of the Circuit Court of Cook County and Howard signed the complaint in the presence of the Watch Commander and the League's attorney, Kermit Coleman.

Howard Saffold then posted bond and left the station, after entering his vehicle which was pared in the police parking lot, an Evidence Technician in a squad car drove his vehicle across the parkway in Mr. Saffold's path. The officer alighted with his gun drawn, Howard rolled down his window and asked the officer to unblock his path; when the officer observed Attorney Kermit Coleman witnessing the even he moved the squad car and we were able to leave the parking lot.

These are essentially the elements of this incident.







### DISCRIMINATORY PRACTICES

Police unions across the country have posed main oppositions to equal employment opportunities (affirmative action) for Blacks and other minorities (this includes females).

- \* Where were these organizations who allege to represent Black and White police officers when minorities needed support in our efforts to stamp out racial discrimination? The City of Chicago and the Chicago Police Department are as guilty of discriminatory practices today as they were when the initial law suit was filed by AAPL. We believe that our struggle for justice is a long way from over, however to this day, no union or organization vying to represent all police officers has demonstrated the intent to aid Blacks in "The Struggle".
- \* Why haven't the heads of COP, FOP, CPA, Union 1975 sat down with the leadership of AAPL and the Guardians Association in order to fashion a true Bill of Rights for All police officers?

### \* NO JOB SECURITY

Unions cannot quarantee there won't be any layoffs -- history teaches us it's a simple equation:

Contract vs. Budget. It happened in New York (28% loss in manpower) and Detroit (33% loss in manpower)—if you let it, it can happen here. Remember: last hired—first fired.

- \* Seniority system undermines younger, more recently hired officers by hampering promotions, excluding them from certain assignments even shift choices and transfers, not to mention furloughs.
- \* Existing pension funds would be put in limbo without protection they now have under Illinois law.

Medical procedures, grievence procedures, accumulated time due, medical care plan, insurance, are all issues yet to be responsibly addressed by organizations vying to be sole representative.

### **\* UNIONS AND STRIKES**

Police unions have proven to be totally unconcerned and insensitive to the sworn responsibility that most officers adhere to concerning public service and protection.

No strike clauses in union contracts have been consistantly ignored by police unions and subsequently public safety has been jeopardized without reservation. Being part of a police union automatial cally compels a member to:

Strike when one is called Picket when so instructed; be fined upon refusal of such directives.

This results in the loss of innocent citizen's lives, your family support \$\$, the respect as professionals we have strived so hard to earn.

### \* THE POSITION OF AAPL AND THE GUARDIANS

on the issues of a police union for Chicago is SOLID. "No Single Representative." The City of Chicago happens to fall on the same side of the tracks for a change. We have not changed our philosophy that police unions have all worked against the public welfare as well as the welfare of Blacks and other minority officers. We are aware of recent surveys which indicate that the members of police organizations with collective bargaining fare no better than others without collective bargaining (in terms of benefits--salaries, etc.), they just pay more dues. Remember, once the deal is cut and an agent named, we will be stuck paying dues to them from now on whether they represent us fairly or not. All police officers should be aware that dues assessment will no longer require their approval once a union is allowed to become sole bargaining agent.

### LET'S STAY CLOSE TOGETHER ON THIS ONE.

We have no one to blame but ourselves if we break ranks on this critical issue.
