THE PRESIDENT'S OPINION

OF THE WISDOM AND EFFECT OF HIS EMANCI-PATION PROCLAMATION.

It has been our good fortune, and we have had much satisfaction in it, to agree, in great measure, with the President of the United States in his opinions as to men and measures in the conduct of the war. We have seen him beleagured by violent men who have sought to drive him into schemes that he could not approve, and we have have seen him steadily re-sisting them, resolved to seek the good of his country and the salvation of the Union, rather than the favor of friends or the interests of pariy.

Last week we published the proclamation which the President has issued respecting the future emancipation of slaves in the revolted This week we have the official report States. of the President's previous convictions as to the expediency and probable effect of the measure. His views were formally conveyed by him to a deputation from a Chicago meeting, and were delivered by the President Sept. 13th.

The Chicago delegation, being introduced to the President, submitted a memorial, calling on him to issue an immediate proclamation of emancipation. The President listened with attention to the arguments by which the memorial was supported, and replied:

rial was supported, and replied: The subject presented in the memorial is one upon which I have thought much for weeks past, and, I may even say, for months. I am approached with the most opposite opinions and advice, and that by religious men, who are equally certain that they represent the Divine will. I am sure that either the one or the other class is mistaken in that belief, and perhaps, in some respects, both. I hope it will not be ir-reverent for me to say that, if it is probable that God would reveal his will to others on a point so connected with my duty, it might be supposed he would reveal it directly to me. For, unless I am more deceived in myself than I often am, it is my carnest desire to know the will of Providence in this matter. And, if I can learn what it is, I will doit. These are not, however, the days of miracles, and I suppose it will be granted that I am not o expect a direct reviclation. I must study the plain, physical fasts of the case, ascertain what is possible, and learn what appears to be wise and right. Differences of Opinion on the Subject.

Differences of Opinion on the Subject. The subject is difficult, and good men do not agree. For instance, the other day four gentle-men of standing and intelligence from New York called, as a delegation, on business con-nected with the war; but, before leaving, two of them earnestly beset me to procleim general emancipation, upon which the other two im-mediately attacked them. You know, also, that the last session of Congress had a decided ma-jority of anti-slavery men, yet they could not decide on this policy, and the same is true of the religious people. Why, the rebel soldiers are praying with a great deal more earnestness, a fear, than our own troops, and expecting God to favor their side; for one of our soldiers, who had been taken prisoner, told Senator Wilson, a few days since; that he met with nothing so discouraging as the evident smeerity of those he was amorg in their prayers. slavery as their instrument. I will also concesse that emancipation would help us in Europe, and convince them that we are incited by some-thing more than ambition. I grant further, that it would help somewhat at the North, though not so much, I fear, as you and thoso you represent imagine. Still, some additional attength would be added in that way to the war. And then unquestionably it would weak-en the rebels by drawing off their laborers, which is of great importance. But I am not so sure we could do much with the blacks. If we were to arm them, I fear that in a few weeks the arms would be in the hands of the rebels; and, indeed, thus far, we have not had arms enough to equip our white troops. enough to equip our while troops. Mr, Lincoln Fears the Border Slave States. I will mention another thing, though it meet only your scorn and contempt. There are fifty thousand bayonets in the Union armics from the Border Slave States. It would be a serious matter, if, in consequence of such a proclama-tion as you desire, they should go over to the rebels. I do not think they all would—not so many, indeed, as a year ago, or as six months ago—not so many to day as yesterday. Every day increases their Union feeling. They are also getting their pride enlisted, and want to beat the rebels. Let me say one thing more:— I think you should admit that we already have an important principle to rally and unite the people in the fact that constitutional govern-ment is at stake. This is a fundamental idea, going down about as deep as anything. Do not misunderstand me, because I have mentioned these obj-cions. They indicate the difficulties that have thus far prevented my action in some such way as you desire. I have not decided against a proclamation of liberty to the slaves, but hold the matter under advise-ment. And I can assure you that the subject is on my mind, by day and night, more than any other. Whatever shall appear to be God's will I will do.

These are the sentiments which we have uniformly held and expressed, and now that the President has reached a determination contrary to his previous convictions of duty, let us hope and pray that God will disappoint his previous expectations of evil to result from the proclamation, and overrule it to the suppression of the rebellion and the re-establishment of the Government over the whole country.

ITS EFFECT ABROAD.

Strong hopes were felt that the proclamation would be hailed in England as evidence that the war here is, in fact, a war against slavery, and the decree would, therefore, secure the sympathy for the North of all foreign powers. The New York Daily Times, a warm Republican pa-per, gives the following sentiments from the London Times, from which we may infer the effect of the proclamation abroad:

effect of the proclamation abroad: The London Times earnestly denounces the policy of the abolitionists of the North in seek-ing to raise the negroes of the Bouth against their mastere. It easys that the idea of the abo-litionists is to organize a series of Cawnpore massacres as legitimate devices of warfare; but it thinks they will not succeed in the attempt. It adds: "Indeed, it is difficult to see how a proclamation by a besieged or fugilitie Prosident can have any greater effect than the documents issued by such Generals as Hunter and Phelps, inciting the negroes to revolt." It insists that President Lincoln will refrain from an act which will in no way advance the Fed-eral cause, but only deepen and make eternal the hatred between the two exections. Though we believe that this proclamation is not all that the exigency of the times and the consequent duty of the Government require— and therefore are not so jubilat over it as many others—still, it is an important step in the right direction, and an act of immense his-toric consequence, and justifies the almost uni-versal gladness of expression and warm con-gratuation which it has simultaneously clicited in every part of the free States. It calls for the prompt and efficient enforement, by the army and navy, of the Conflication act, as passed by Congress, whereby the slaves of all rebels who may be captured, or who may seek protection under the national flag, are to be liberated un-conditionally; and as the great mass of the slaveholders are in furious rebeilion, it emanci-pates more than three-fourths of the entire slavo population, as fast as they shall become acces-sible. It also forbids any person connected with the military or naval service to atrest or send back any fugitive slave whatever. These commands, if faithfully executed by the army and navy, will speedily give a staggering blow to the rebellion. The objectionable features of the proclamation are its avowed readiness to return to bloody stripes and horrible torture and lifelong servitude (if he be not killed out-right) any hunted bondman on the mere cath
